introduction

The School of Homeopathy was founded in Devon, England in 1981 by its current Principal, Misha Norland. We are one of the longest running homeopathy colleges in the UK and play a leading role in creating and maintaining sound educational standards around the world. We are renowned for our approach to self-development, clinical practice, homeopathic philosophy and ethos of enquiry. UK students, upon receiving their Diploma of the School of Homeopathy, are automatically eligible for registration with The Society of Homeopaths. The home study program prepares students to meet the eligibility requirements of North American certification boards.

We offer four consecutive courses that can be taken anywhere in the world through Open University-style home study, or by attendance in the UK if that is possible for you.

Taster Course Year one : Foundation Course Year two : Introduction into Practice Course Years three & four : Practitioner Diploma Course

The home study program for North America is rounded out with yearly regional seminars and clinical workshops as well as supervised early practice. Bear in mind that study is flexible – you can take the time you need to work through the course.

The School is closely partnered with Alternative Training, also based at Yondercott House, who help in many ways, especially organizing enrollments, managing the home study courses and book supplies.

what is homeopathy?

Homeopathy is a system of natural health care that has been in worldwide use for over 200 years. It is recognised by the World Health Organisation as the second largest therapeutic system in use in the world. While it is most popular in India and South America, over thirty million people in Europe also benefit from its use.


The name homeopathy, coined by its originator, Samuel Hahnemann, is derived from the Greek words for 'similar suffering' referring to the 'like cures like' principle of healing. Hahnemann was born in Germany two hundred and fifty years ago. At this time the old world-view was being renovated and traditional beliefs, many flimsily based upon superstition, were being increasingly subjected to the rigour of experimental scrutiny and assessment.

Homeopathy is based on two principles that have occurred regularly throughout the history of medicine, both in eastern and western worlds. The first principle of 'like cures like' can be looked at in several ways. One is to assume that the body knows what it is doing and that symptoms are the body's way of taking action to overcome the illness. This healing response is automatic in living organisms; we term it the vital response.

The application of a correct homeopathic medicine increases the body's ability to take this action and so makes the body's own healing more rapid and effective. In chronic illness, this vital stimulus literally lifts the suffering person over the stumbling block of their disease. Before the medicines are decided upon, their curative powers are discovered by testing them out on healthy human subjects and carefully noting emotional, mental and physical changes. This is termed a 'proving'. This information constitutes the basis for 'like cures like', for a medicine's unique symptom picture must match up with the individual's expression of the disease. The second principle, that only 'the minimum dose' should be employed, is based upon the understanding that the stimulus of the medicine works from within the vitality and is not imposed from the outside. Only enough is administered to initiate the healing process which then carries on, driven by its own internal healing mission.

Why is it so popular?

- Homeopathic treatment works with your body's own healing powers to bring about health and well being.
- Patients are treated as individuals, not as a collection of disease labels.
- Homeopathy treats all your symptoms at all levels of your being – spiritual, emotional, mental and physical and finds the 'like cures like' match for them.
- Homeopathically prepared remedies, providing the minimum dose, are gentle, subtle and powerful. They are nonaddictive, and not tested on animals.

our approach

Heart and soul

We have a vision of an open, shared, experience of homeopathy, where asking 'how and why' is valued as highly as knowing the answers to questions. Your personal mode of learning is taken into account, whether your background is artistic, intellectual or scientific. We put our heart and soul into self-discovery, as well as into finding ways to heal others. To help this along, we provide a tranquil environment where non-violence and self-awareness are practiced.

Many years of experience

We are proud of the quality, knowledge and diversity of our faculty. Teachers, mentors, tutors and supervisors are all experienced and practising homeopaths of long standing, offering you their wealth of personal experience. They provide you with a coherent healing philosophy validated by making people healthier.

Healing method

The healing method we teach is the 'classical' homeopathy of Samuel Hahnemann, as described in his 'Organon of Medicine', elaborated upon by Kent and current practitioners at the forefront of homeopathic development. Our teaching team are motivated to bring innovative methods into clinical practice. We have incorporated the insights of Jan Scholten and continue to be inspired by Rajan Sankaran. This enthusiasm for new insights will keep you abreast with current thinking as you learn the time-tested approaches alongside the newest discoveries.

Thinking and feeling

The School's approach to the study of homeopathy is experiential. In the initial stages of learning, particularly of medicinal substances, this involves a blend of detailed academic study and insights derived from being in tune with the dynamic 'vital being' of the medicines. Latterly, the empathetic approach is championed in casework. This is because a homeopath's art depends upon understanding the dynamic disturbance in the suffering individual and matching this with the dynamic energy of the medicine. As you progress through the course, you will be guided in techniques of synthesis, using diverse sources of information to form a coherent understanding. In this work, you will be inspired by Misha Norland's approach, which artistically exemplifies synthesis: the blending together of many elements to deepen understanding.

Helping you grow

There are no exams. We use a continuous assessment scheme that is designed to stimulate your creativity and which is based upon regular and in-depth assignments and personal feedback from mentors and tutors. This person-to-person contact provides you with educational support as well as evaluation. As you proceed in the course, the emphasis becomes increasingly patientoriented. Once you begin in practice your personal clinical supervisor plays an integral role in your development as a healer and prescriber of homeopathic medicines. By carrying out the academic work to a sufficient depth and by going on to practice under supervision, you demonstrate your growing skill and can progress to receiving your diploma and sitting for the North American board exams. Quite naturally, you will build your own practice with confidence. Our encouragement for self-reflection throughout also provides a formula for your continuing professional development.

Our Independent Status

The School of Homeopathy has decided to remain independent at a time when numerous homeopathic colleges are turning to a university campus for the benefits of degree status. For our students, the informal, natural and healing atmosphere of Yondercott, with its small classes, is a blessing that cannot be replicated in the institutional setting of a campus course. This also allows us, unhindered by institutional agendas, to continue in providing the forwardlooking ethos and flexibility for which we are renowned.

study program

Our courses build upon one another. Study time is flexible, and you can start at any time. You can choose to begin slowly, just sampling the offerings, or you can enter on a complete course of study, which blends the independence of home study with the practical work of clinical training.

Taster Course

Home study with or without a tutor.

Year one : Foundation Course

Home study with tutor and a seminar.

Year two : Introduction into Practice Course Home study with tutor and a seminar, Anatomy & Physiology.

Years three & four : Practitioner Diploma Course

Home study with tutor, a seminar, two clinical workshops, Pathology & Disease and personal early practice supervision.

home study

Our home study courses follow a similar curriculum to the attendance program at Yondercott House. We take the very best of the School's work and teaching and bring it to you, at home. It is ideal for anyone who requires flexible learning. Study can be started whenever you like and the courses can be spread over time so they can be fitted into busy life schedules.

You receive encouragement and guidance from a personally assigned tutor who supports you throughout your endeavours, giving extensive written feedback on your assignments. Mentors and tutors are practising and fully qualified homeopathic practitioners, chosen for their skills in helping you learn. The home study manager, Amanda Norland, supervises your progress, and is available for queries or pastoral care. We also have other in-house facilitation, should any problems be beyond our scope to solve. If you have e-mail access, then this is the most effective way to send in your assignments and to ask any questions regarding your study.

You have the benefit of carefully edited CD recordings of classroom teachings, CD's of actual cases and interactions, plentiful amounts of underpinning information, and numerous examples of past students' work. You are guided through the topics by reference to books as well as by specifically written explanations, descriptions and diagrams. You check your progress and reinforce your learning through selfassessment questions and model answers. At the end of each study unit, you send written assignments to your tutor for feedback and assessment. Self-reflection plays a crucial role in your learning and later in developing your skills in casework.

clinical training

Your independent study is supported and strengthened by face-to-face sessions with fellow students and senior staff. Seminars support your home study learning, assessed clinical workshops further develop your advanced casework and materia medica skills, and clinical supervision supports your early practice.

Seminars

Every year we arrange several 3-day seminars at various locations around the U.S. and Canada. These interactive sessions led by Misha Norland and other senior members of the School's faculty help you connect theory with the reality of practice. Many of these sessions use video and/or paper cases to illustrate case taking, case analysis, materia medica and philosophy, and some include aspects of personal skill development.

Workshops

We arrange at least one clinical workshop in North America and one in Devon each year. Workshops are intensive 7-day residential sessions, normally directed by Misha Norland and another senior member of our School faculty. These sessions develop your abilities for effective case management. Large and small group interactive work refines and enhances your homeopathic and personal skills, helping prepare you for starting practice.

Other clinical training

We encourage you to gain as much additional experience as you can from other clinical seminars, courses and clinical observation. Although there is particular benefit from attending our workshops, our links with other schools in North America may allow us to grant exemption from those if you have completed certain other clinical courses, e.g. the Dynamis or Luminos programs. If exemption is granted, however, you will still need to complete our assessments to gain our Clinical Certificate. Additional clinical training options are also available. As these change frequently, please contact us for current information.

the courses

The School's education progresses through four levels:

Taster Course

If you are interested in homeopathy but not yet sure if it is for you or if you want to sample the quality of our material, then you can nibble at the first two units of our Foundation Course through our home study Taster Course.

Year one : Foundation Course


If you like the idea of studying homeopathy but are not yet sure that you want to go into practice, then you can enroll on our Foundation Course.

Year two : Introduction into Practice Course

If you want to learn more about case work and are inspired to become a homeopathic practitioner then you can carry on into the Introduction into Practice Course.

Years three & four : Practitioner Diploma Course

If you wish to become a professional, then after you have completed the Foundation Course and Introduction into Practice Course, you carry on into the Practitioner Diploma Course - one leads seamlessly into the next. Each course comes with a book list. We supply the books by mail order through Alternative Training, obtaining specially discounted rates. Books are also available through homeopathic bookstores and mail order sources in the U.S. and Canada.

taster course

This course is perfect if you cannot quite make up your mind and wish to taste homeopathy and assess the quality of our teaching material.

The course begins by introducing you to the work of Samuel Hahnemann. It lays out a broad canvas upon which we begin to paint a picture of homeopathic philosophy, some of the fundamental principles of prescribing, and some in-depth portraits of medicines, introducing you to their psychological and physiological healing potentials.

You have the option of buying the course with or without tutor feedback and marking. This means you can read the material and try your hand at a few assignments. If you wish to join us, you then transfer onto the Foundation Course, and compute all the assignments for the Taster course units and send them to your new tutor. Our Taster Course requires only a few books from Book List One.

Home study

Time: Nominally 2-4 months, however this timing is up to you. Study: Units 1-2.

Taster Course topics Include:

Hahnemann and some background history of homeopathy; the law of similars; the science of homeopathic provings; the organization of material medica; homeopathic pharmacy; symbolic as well as medical interpretation of illness; the vital force and the vitalistic view of life; some exploration of the interactions of psyche and soma.

CD lectures on materia medica: Aconite, Arnica, Belladonna, Bryonia, Chamomilla, Pulsatilla, Rhus Tox, with in depth studies of Calcarea Carbonica and Sulphur.

year one : foundation course

As well as being the starting point for the Practitioners Diploma Course, our Foundation Course is ideal if you wish to learn about the theory of homeopathy, but might not want to go on to become a practitioner.

The Foundation Course makes a complete arch, from first principles to the finished structure of classical homeopathy. Philosophy is covered in great depth and various approaches for studying materia medica are given, helping you find the way that works best for you. The approach is completely classical, based upon Hahnemannian and Kentian principles. The Foundation Course has allowed many students in the UK to progress onto year two, not only at our own School, but also at other establishments – its high standard being recognised and appreciated as a sound structure to build upon.

Book List One is required for this course. Alongside the Foundation Course, if you wish to go onto the Practitioners Diploma Course, you will also be required to complete Alternative Training's Anatomy & Physiology Course unless you already have equivalent training.

Home study

Time: Nominal, but flexible, 1 Year period. Study: Units 1-7, plus one 3-day weekend seminar.

You attend one 3-day seminar, but are invited to do more . We offer several seminars in different regions of the US and Canada from spring through fall. They provide specific guidance on casework through the medium of video recordings and workshop-style learning experiences with senior lecturers or tutors from the UK. The Foundation Certificate is awarded after successful completion of Unit 7 and one 3-day seminar.

Further study options

You are welcome to join UK tutor study days or Foundation Course School weekend sessions if you wish; just call us in advance so we can arrange it. There are also regional study groups.

Foundation Course topics include:

Hahnemann and some background history of homeopathy; the law of similars; the science of homeopathic provings; the organisation of materia medica; homeopathic pharmacy; symbolic as well as medical interpretation of illness; the vital force and the vitalistic view of life: some exploration of the interactions of psyche and soma, plus: Hering's Law; recognising signs and symptoms; how to take the acute and the chronic case; knowing when to be receptive and when to be proactive and which questions to ask; perceiving what needs to be cured; symbolic as well as medical interpretations of illness; hierarchies of symptoms and evaluation of their relative importance; acute, chronic and iatrogenic diseases; susceptibility; the doctrine of polarity; homeopathic repertory; how to understand and find rubrics Underpinning the study of materia medica is an exploration of remedy signatures.

CD lectures on materia medica: Aconite, Arnica, Argentum Nit, Arnica, Arsenicum Alb, Aurum, Baryta Carb, Belladonna, Bryonia, Calendula, Calcarea Carb, Carbo Veg, Causticum, Chamomilla, Eupatorium, Ferrum Phos, Gelsemium, Ignatia, Ipecachuana, Lachesis, Lycopodium, Medorrhinum, Mercurius, Natrum Mur, Nux Vomica, Phosphoric Acid, Phosphorus, Pulsatilla, Rhus Tox, Sepia, Silica, Staphisagria, Sulphur, Tuberculinum.





year two : introduction into practice course

The Introduction into Practice Course is ideal if you wish to take the Foundation studies to the next level. The course looks at some of the deeper philosophical aspects of homeopathy and further investigates case taking in preparation for practice under supervision.

During this part of the course we focus upon casework, introducing you to both the theory and practical applications of two systems for interpreting imbalance and diseases: Hahnemann's theory of miasms and a system based upon constitutions and temperaments, the Mappa Mundi. The theory of miasms is developed in Misha Norland's book, *Signatures, Miasms, AIDS* while lectures and audio tracks on CD extend this into the analysis of patients' cases to complement the classical methodology outlined in our Foundation Course. The distinctive approach of the School of Homeopathy is made evident through the application of the Mappa Mundi as well as the remedy signature teachings – these concepts are partly responsible for our uniqueness, alongside the nurturing tutoring and the academic rigour. It is often commented, that many of our students find a spiritual connection to the work and to healing, and of course, we are delighted to be associated with this.

Book List Two complements this course. Alongside the Introduction into Practice Course, if you wish to go onto the Practitioner Diploma Course, you will also be required to start Alternative Training's Pathology & Disease Course unless you already have equivalent training.

Home study

Following on from the Foundation Course. Time: Nominal, but flexible, 1 Year period. Study: Units 8 - 14, plus one 3-day weekend seminar.

You attend a minimum of one 3-day regional seminar. If you are going to go onto the Practitioner Diploma Course then you should begin your Pathology & Disease course during this time. The Introduction into Practice Certificate is awarded after successful completion of Unit 14 and your second seminar, plus the Anatomy & Physiology course.

Further study options

We offer annual, 7 Day Summer Schools in May/June at Yondercott. We warmly invite you to come to one of these sessions if possible. You are also welcome to join UK tutor study days, Weekend Summer Schools or second year School weekend sessions; just call us in advance so we can arrange it.

Introduction into Practice Course topics include:

Beginning in-depth analysis of chronic cases; anamnesis; prognosis; the evolving theory of Miasms and its practical interpretation; the matching of potency to the patient; reviewing plans and strategies for case analysis; evaluating the effects of suppression and other blockages in any given case; evaluating the response to treatment and when to give a second prescription; reviewing the Organon; reviewing Kent's philosophy; introducing the Mappa Mundi and beginning to apply it to casework and remedy synthesis. CD lectures on materia medica: Alumina, Anacardium, Antimonium Crud & Tart, Apis, Cannabis Indica, Calc Phos, Calendula, Camphora, Carcinosin, China, Cimicifuega, Colocynthus, Conium, Cuprum, Drosera, Helleborus, Hepar Sulph, Hyoscyamus, Hypericum, Kali Carb, Ledum, Lillium Tig, Nitric Acid, Opium, Platina, Plumbum, Psorinum, Pyrogen, Stramonium, Stannum, Syphilinum, Tarentula Cub & Hisp, Thuja, Veratrum Alb.





years three & four : practitioner diploma course

Our Practitioner Diploma Course is designed for anyone interested in becoming a professional homeopath. Our highly regarded program instils the expertize and knowledge to become a confident and successful homeopath.

During the course we continue to develop many of the concepts learnt in the Foundation and Introduction into Practice Course but with the emphasis on increasing your skills in case receiving, analysis and prescription, to prepare you for practice. Various approaches are given to help you unravel cases, such as group classifications and elemental archetypes. We encourage the use of creative ideas such as these as they often tell us as much about ourselves as they do about the subjects being studied.

Detailed casework takes place using material generated from the extensive library of recordings at the School. Various models for case analysis are explored, with lecturers presenting those that they have found particularly useful in their practice. These case studies enhance understanding enormously. They encourage the closest scrutiny that in turn leads to an awareness of what needs to be cured and the subsequent establishment of a relevant hierarchy of symptoms. Use of the repertory and differential comparison of materia medica then leads to a selection of the most appropriate remedy.

Book List Three is recommended for years 3 & 4. Alongside the Practitioner Diploma Course you will also be required to complete Alternative Training's Pathology & Disease Course unless you already have equivalent training.

Becoming a Practitioner

Case-work under supervision is the crucial aspect of the Practitioner Diploma and your development as a homeopath. We ask you to take at least ten cases with follow-ups over a period of at least one and a half years. During this time you work closely with your supervising practitioner.

You and your supervisor will undertake a thorough and progressive evaluation of your skills, an important part of which will be your own reflection of what is being learned from each case-taking and about your practice in general.

These cases, their follow-ups and ongoing prescriptions, will be assessed regularly and then again as a complete case portfolio at the end of your study. By demonstrating professional competence and appropriate academic standards you will complete the School's Practitioner Diploma.

Home study and clinical training

Following on from the Foundation and Introduction into Practice Courses. Time: Nominal, but flexible, 2 year period Study: Units 15-18, a minimum of one 3-day seminar and two 7-day clinical workshops, case work under supervision and self-reflective practice evaluation.

Once you have completed the home study Years One & Two you can move onto Years Three & Four. The Advanced Certificate is awarded after Unit 18 and the Pathology & Disease course. The Clinical Certificate is awarded after completion of three seminars and two workshops.

You qualify for our Practitioner Diploma with evidence of your clinical expertize through practice under supervision. This can be completed in one and a half years but you are given up to three years. There are two options: 1. You can find a homeopath local to you with whom you can sit in and who can act as a supervisor. (There is a protocol which can be obtained through the School.) 2. You can use one of the supervisors from our network. if they are some distance from you, then you may consider e-mail communication. These cases, their follow-ups and prescriptions, will be assessed on an ongoing basis and then again as a case portfolio at the end of your study. By demonstrating professional competence you will complete the School's Practitioner Diploma.

We will also keep you in touch with the newest case analysis techniques and upto-date practice information at our clinical workshops. Here Misha Norland and Janet Snowdon, both gleaning homeopathic insights internationally, facilitate advanced students as they progress towards autonomy and confidence in practice.

All students attend a third seminar and two week-long clinical workshops, one of

which may be our yearly 7-day international Summer School in May/June at Yondercott.

Study options at Yondercott

You are most welcome to join UK tutor study days, 3rd and 4th year School weekend sessions, and International summer school. Just call us in advance so we can arrange it for you.

Yondercott House has well-appointed and beautiful rooms, filled with light, warmth and serenity. We also have a reference library and computer facilities, as well as the practice clinic with its video link to the teaching room. The house is surrounded by extensive mature gardens where many medicinal plants thrive, together with woodlands, where we like to walk, talk and relax. Yondercott provides a tranquil environment conducive to reflective study where the busy world can be left behind and we can appreciate life's ever-renewing cycles and seasons.

Practitioner Diploma Course topics include:

Taking the case and prescribing for babies and children: treatment of chronic cases: dosage and repetition; assessment of response to the first prescription; the second prescription; prognosis; prescribing for acute flare-ups during constitutional treatment; long-term case-management; understanding symptoms with reference to the constitution of the patient and her/his relationship to the four temperaments; use of language, symbolism and imagery, plus new methodologies and new provings of remedies as they arise during casework. You will also gain an understanding from the grouping of remedies into categories that include:

- therapeutic indication
- remedy relationship (such as complementary or inimical)
- familial relationships (such as specific plant or animal genus)
- the Sankaran schema
- mineral compounds group analysis
- the periodic table of elements (as taught by Jan Scholten)
- Elemental groupings the four temperaments and the Mappa Mundi

Lectures on materia medica include: Chelidonium, Cicuta, Ferrum, Lac Caninum, Natrum Carb, Zincum, and many others through the case analysis work undertaken during the course.

The information provided is freely available to anyone for study or research.

medical science courses

The School uses Alternative Training's medical science courses. They are widely recommended and used as an integral part of training by many colleges and societies in the UK and around the world where they meet with rigorous medical science requirements.

The study of medical sciences is an essential part of the education of the homeopathic practitioner.

- It enables the practitioner to distinguish symptoms common to disease from those that are idiosyncratic to the patient – the latter being invaluable for a proper homeopathic assessment.
- It enables the practitioner to know how the disease is likely to progress should treatment be ineffective.
- It helps the practitioner know when to re-prescribe or to refer to another health-care specialist or medical doctor.
- It helps communication and confidence both with patients and other health professionals.
- It provides an understanding of conventional diagnosis, prognosis and treatment, and how these may affect and modify management of the case by the homeopath.

The Anatomy & Physiology Course (A&P) teaches you about the human body and its basic functions, while the Pathology & Disease Course (P&D) explains the concepts of diagnosis and treatment used by orthodox medicine and gives advice on the application of this knowledge in alternative practice.

In each course you are guided through the topics by reference to supplied textbooks and given supporting explanations, descriptions, and diagrams. You check your progress and reinforce your learning through self-assessment questions with model answers. At the end of each study unit you send written assignments to a specialist tutor for assessment and helpful feedback. We recommend that you begin the A&P soon after starting the Foundation Course. P&D ought to be started at the beginning of the Introduction into Practice Course and must be completed before the Practitioner Diploma. Exemption may be granted for equivalent prior study, but you may still wish to take the courses without tutor marking to refresh or expand your knowledge.

Anatomy & Physiology Course

An introduction and comprehensive study of Anatomy & Physiology. This includes: organization of the body into cells, tissues, organs, and systems; cell division and growth; blood; nutrition; homeostasis; defence mechanisms against disease; skin; reception of stimuli by the eye and the ear; reproduction.

By the time you have completed this course you will be able to identify, locate and describe the main components and functions of the cardiovascular system, respiratory system, gastrointestinal system, urogenital system, endocrine system, musculoskeletal system, and nervous system. You will also know how to study more details of any of these aspects if your clinical work requires it in the future.

Pathology & Disease Course

Introduction and discussion of the philosophy of pathology, study of basic pathological processes, common medical investigations, infectious disease, cancer, cardiovascular system, respiratory system, urinary system, musculoskeletal system, dermatology, special senses, gastrointestinal system, central nervous system, endocrine system, obstetrics, gynecology, children's health, and psychological disorders.

Within each topic, the focus is on identification of symptoms, keys to recognizing serious disease (where caution is needed), the use of diagnostic investigations, the components of specific disease states, and the management of these conditions by alternative practitioners, including the ability to communicate with orthodox medical practitioners.

Nutrition Course

This course is also offered by Alternative Training, and is an optional 125-hour module that is not part of the main study but which will provide supporting knowledge for your practice. It gives you a sound understanding of the scientific basis of nutrition – please contact us for details or visit www.alternative-training.com.

assessment & certification

Assessment

There are no formal examinations, assessment is continuous, initially through regular assignment projects. You will be assisted by supportive and thought-provoking comments from your tutor and later by your clinical supervisor. Your abilities in case analysis and management during clinics are noted. Tutors play a key role in listening to you and providing a meta-view of your progress. Any perceived weaknesses in your understanding will be discussed with you, while you will be aware of any missing assignments yourself. We may re-contract with you, for instance, in agreeing to extend the time frame of your studies or your case supervision. We find our students benefit most when encouraged to self-assess and selfreflect so we do not use a marking grade or percentage system.

Certification

The School awards Certificates and Diplomas on the completion of each of the four courses:

The Taster Credit (when you complete assignments and do not wish to extend your study) The Foundation Certificate (for the one year exploratory course) The Introduction into Practice Certificate (for the two year course) The Clinical Certificate (at completion of workshops, assessments and medical science course work) The Practitioner Diploma (for the full 4 year program)

Our UK Program is fully recognized by the Homeopathic Medical Association and The Society of Homeopaths, the British representative on the European and International Councils for Classical Homeopathy and meets the academic requirements to sit for the North American Council on Homeopathic Certification exam.

Please note that completion of our program does not confer a license to practice. Whilst we have a very high reputation, it is wise to review the official licensing policies of your own state or province before setting up in practice. Many of our students apply to CCH for certification following graduation.

entry requirements

Our courses are open to anyone with a sincere interest in the study of homeopathy irrespective of your background. There are no high level academic entry requirements for joining our courses, rather we ask for you to come with an open mind and heart and a genuine vocational aptitude. Healing talents and commitment are emphasised, and life experience counts for a lot. What we are looking for here is your capacity to study and to express yourself rather than your prior learning. You will need English as a first or second language and it is essential that you enjoy researching and are interested in the natural world.

Advanced Entry

For those with prior homeopathic knowledge, we have advanced entry points to our courses. To be considered for partial exemption you will be required to show study equivalent to our courses, and you must provide full details of your previous training, including methods of assessment, clinical experience and homeopathy textbooks used. Acceptance is then provisional; you may well be asked to complete a preliminary unit that serves to show you our methods and teaching standards and enables us to assess your prior learning.
